### Scope of waiver

- » In the event of a positive decision, all service fees for winners will be waived with the awards »Gold«, »Winner« or »Special Mention«.
- » Mandatory fees for the registration are excluded from this process.
- » Fees for the Nominee Package as well as other optional services are also excluded.

### Requirements

- » Each company can submit a maximum of three grant applications

- » Registration confirmation for the awards (delivery via email after successful online registration)
- » Official sales statements, which have been confirmed by the tax authorities or tax accountant, from the years 2019 and 2020 in German or English. Certified translation for sales statements in other languages.

### Submission deadline

The German Design Council makes its decision regarding a waiver based on a formal review. The application must have been submitted to the German Design Council together with the competition registration by 21 January 2022, including the date of receipts. Applications received after this date can no longer be considered.
